TOWN ADMINISTRATOR'S REPORT

1. Oil collection at Hedley Transfer Station – The existing collection tank has developed a leak. Waste Oil collection at the Transfer Station will be suspended for the next two weeks due to a DEM required clean-up and repair notice. DPW will be working with the Station Operator to pump the waste oil, remove and replace the tank, and clean-up the containment area.
2. Paid part-time summer internship opportunity – The Portsmouth Canvassing Authority is offering an opportunity for one high school Junior to serve our community as a student member of the Board of Canvassers. The appointment includes a paid, part-time, summer internship with a modified winter schedule. Completed applications must be received by the Human Resources Office no later than 12:00 PM, Wednesday, May 1, 2019.
3. Status of Sakonnet River Bridge – Request to Rescind ROD – On April 11, the Town received a letter from the FHWA notifying us of their proposal to rescind the Revised ROD for the Sakonnet River Bridge. The letter was sent to all stakeholders in the project and have until May 7 to submit any comments they may have pertaining to the decision to rescind the ROD. Barring any comments to the contrary, the FHWA will rescind the ROD after the comment period.
4. Phelps House update – Since my last update, we have met with the proposed concessionaire for the Phelps House property. A draft agreement has been worked out and we expect a final draft will be ready for your review and approval in May.
5. Visit by Congressman Cicilline – On the 17th, members of Town and School staff met with Congressman Cicilline to discuss ways the he could support Town and School priorities. In review of a few items from our meeting: the Congressman is working to include a funding stream available to support new community facilities in the new infrastructure bill; he and our DC legislative staff will continue their focus on funding for resiliency and hazard mitigation; we also discussed various USDA Rural Development Programs, some of which may be a good fit for projects on Prudence Island and Hog Island (wastewater, broadband, etc.).
6. Brown House update – The Newport County Prevention Coalition has committed to renting two offices starting May 1. Additionally, they will probably seek a third office starting in June. The SIREN group has decided not to seek office space but is working with the Recreation Director to prepare an MOU for the conduct of fee based adult learning workshops.
7. Dog licensing reminder – Just a reminder that dogs must be licensed by April 30 with a proof of rabies vaccination. The RI Veterinary Medical Assoc. is still conducting low-cost rabies clinics that can be taken advantage of. A link to the rabies clinics can be found on the Town's website.
8. Upcoming Police Awards ceremony – An additional reminder for the Council, the annual Police Awards Ceremony will be held at the Glen Manor House on Thursday, May 23rd at 5:30PM.
9. Request for Portsmouth Award nominations – In May, the Town will be seeking nominations for the annual "Portsmouth Award." The award is presented annually to an individual, business, or civic group who has consistently demonstrated excellence in community leadership producing significant results directly benefiting the community and its citizens. A press release will be issued this week and information will be available on our web-site. Nominations will be due by May 31st.
10. Police building construction report – Since the last report: Demolition of the old station was completed last Wednesday; Retaining walls are due to be completed this week; An unknown UST will be removed this week; Hydro seeding will commence this week; There will be several days over the next month where people will be diverted to an alternate entrance to the building due to paving and sidewalk construction; Weather permitting, site work will be completed by May 31st; No new change orders have been received since the last report, but we know there is at least one CO outstanding and under review. Over the next month we will be working with our Owner's Rep, the Builder and the Architect to reconcile remaining balances and clear outstanding punch list items. A final report will be presented to the Council in June. Again, the dedication ceremony will be held at 9:00AM on Friday, May 31st.
