Dear Mr. Rainer:

Quaker Manor is a public housing property providing affordable housing for 40 elderly and disabled residents in Portsmouth. Portsmouth Housing Authority is converting Quaker Manor to private ownership under HUD's Rental Assistance Demonstration (RAD) initiative. The new owner will be Quaker Manor LLC, a single asset entity. Portsmouth Housing Authority, governed by a Town-appointed Board of Commissioners, will be the sole corporate member of Quaker Manor LLC.
