TOWN ADMINISTRATOR'S REPORT

- 1. COVID Update
 - We are still in Phase Three and it is important for everyone to continue to adhere to the DOH COVID guidelines. Please continue to monitor our COVID web page, which is amended every Wednesday.
 - Of note, the Governor is urging everyone to get tested especially those who regularly work or congregate in close quarters with others. More information is on our website, but it is simply a matter of going to portal.ri.gov to schedule an appointment.
- 2. Halloween Update
 - The Governor is asking everyone to cancel Halloween parties and has requested the State Police to increase their enforcement of COVID Guidelines. Trick-or-treating is permissible in small groups with face coverings but is encouraged to be completed before dark. Please go to the Town Website for information regarding safe Halloween-themed activities and additional guidance; including:
 - o The Recreation Department "All Treats no Tricks" drive-through event on Friday, October 30th at the Brown House from 4 to 6 PM.
 - o The Portsmouth Police Department Trick-or-Treat Drive-by Event on October 31st at the Portsmouth Police Station from 12:00 to 4:00.
- 3. Status of Finance Software
 - The School department has now migrated from our legacy financial system to our new finance software.
 - On the Town side all modules, with the exception of fixed assets and e-procurement have been implemented. We will continue to operate in parallel with the legacy software and anticipate the transition to be completed sometime in February.
- 4. New Portsmouth Prevention Coalition Chair
 - Marianne Raymo is stepping down as the Chair of the Portsmouth Prevention Coalition. In her place, the Coalition has elected Jenn Collins as the new Chairperson. Jenn grew up in Portsmouth and is a Portsmouth parent. She has volunteered for various school groups and we're excited to start working with her.
 - I'd like to acknowledge the hard work of Marianne and thank her for her service to Portsmouth.
- 5. Delivery of New Fire Boat
 - We took delivery of the Fire Department's new boat last week.
 - Department personnel will be testing the boat and conducting training for the next couple weeks and the boat will be placed in service by the second week in November.
- 6. Take-It-Out RI Grant Program
 - The Town has been awarded a grant of up to \$51,000 under the "Take-it-Outside" initiative.

- Eligible Expenses may include the cost affiliated with purchasing, obtaining, delivering, installing, or otherwise enabling the use of items and goods and services, before December 18, that are necessary to increase the Town's outdoor opportunities. This includes help to restaurants and other enterprises and recreational events. As soon as the formal agreement is executed with the RI Dept of Commerce, the Town will start accepting proposals from eligible entities.
